


Hope you're well.

We have identified a number of jobs which need urgent attention in Kinmel Bay Bowling Green play area, listed below.

- (1) Replace the gate motor on one of the safety gates – We have parts in stock for this.
- (2) Replace rotten decking on the Ship Multi-play-unit (MPU), shown below. I have attached a quote for parts which we require to complete this work. The quote includes a replacement post end cap.





Action: Replace all affected timbers

- (3) Replace split plastic panel on the Castle MPU. – This is being supplied FOC by the manufacturer as it is still under warranty.
