One of the main items of interest is the impact of tourism on the local health economy – not unique to Kinmel Bay but it does have a level of impact far and away above that of many other parts of North Wales. For a number of reasons, local primary and secondary care services do not received remuneration for this extraordinary level of activity. Some of those in attendance were suggesting use of the tourist tax in order to address the effect of large numbers of tourists. This is not an issue that Llais would have a view on, but we will be asking local government colleagues about this as part of our follow up. We will also ask Betsi Cadwaladr for their thoughts on the issues raised by people in Kinmel Bay. We will write to you again when we have received those comments.
