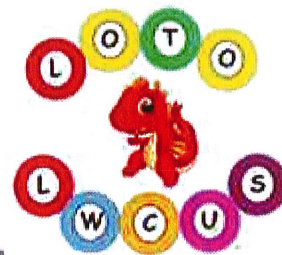

Thank you for your email and application. We've had a quick look through, and the majority of the application looks to be in order.

There are a couple of points to consider.

Is it possible to get some location images of the current site with the lights and the area to be provided with the solar lights as well?

Can you confirm the amount you are also requesting from Gwynt y Mor, is it £9,000 or £1,300?

I also know we've discussed the point in relation to the land ownership previously and that the Town Council will be responsible for the maintenance of the lights, and I've noted there is a signed agreement between the main council and the Town Council provided with the application.

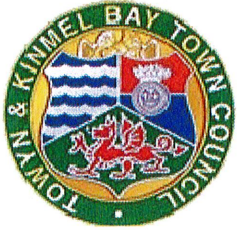
