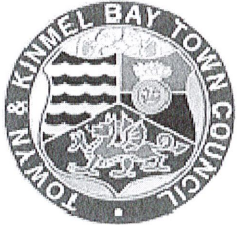

Two of our councillors removed well in excess of 100 vodka bottles from the CCBC car park only a few weeks ago.

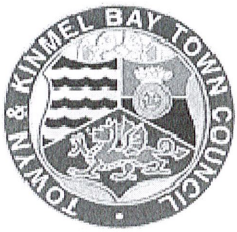

The Town Council has identified a fourth potential location for a CCBC Public Space CCTV Installation in the Towyn and Kinmel Bay Area:-

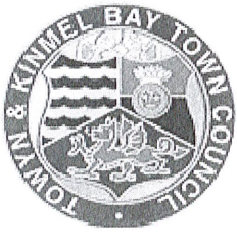
