Good morning Dylan,

Hope you had a nice break with the Bank Holiday.

We have received observations from Cllr Kay Redhead regarding the condition of the large 'space ship' climbing frame in Chester Avenue Play Area. These issues have been identified through our inspection regime and we have already obtained quotes for the replacement of the safety surfacing. The work will be going ahead this summer. Funding for this work has been obtained from the UK Government 'Levelling Up' fund.

Regarding the worn ropes on the climbing frame, these are being monitored and will be repaired or replaced as and when funding becomes available. As you are probably aware we do not have a playground capital budget for 2024/25, so any works will have to be funded by local councils, where possible.

Can you could please make all councillors aware of the above information.
